## UN Subcommittee on Prevention of Torture (SPT)

On 18.10.2023, on the Sub-Committee's website it was announced that the UN Subcommittee for the Prevention of Torture (SPT) conducted its first visit to Georgia from October 8 to 14, 2023, to evaluate the treatment of individuals deprived of their liberty and the measures taken to protect them from torture and ill-treatment. UN experts noted that Georgia has made significant progress in combating torture and improving detention conditions, but extra measures are necessary to lower prison population, expand staff force, strengthen rehabilitation programs, and bring the prison system up to 21st-century standards.
